- (ii) The engagement will be on full time contract basis for a period upto 30.06.16 or availability of regularly selected candidates which ever is earlier. The contract can also be renewed as per the policy laid down by Ministry of Railways (Railway Board).
- (iii) For reason in addition to above, the contract shall be liable to terminated by giving two week notice by either side without assigning any reason, or if the selected candidate on contract is mentally/physically incapacitated.
- (iv) Contract engagement shall not confer any right for regularization or absorption in the post. Remuneration is consolidated and Railways do not give any additional perk/ facility.
- (v) In case of dispute, the notification published in English version shall prevail.
